

CITY OF SAUSALITO NOTICE OF CITY COUNCIL AND PLANNING COMMISSION JOINT PUBLIC HEARING FOR THE REVIEW OF THE DRAFT HOUSING ELEMENT

You are invited to attend a joint City Council and Planning Commission joint public hearing on the following project.

PROJECT DESCRIPTION

Review of the draft Housing Element prior to submission to the State of California Department of Housing and Community Development (HCD). The Housing Element is the component of the City's General Plan that provides a vision for housing and is the blueprint for future housing development in the City. It includes goals, policies, and programs, including the following topic areas:

- Maintaining and enhancing the quality of existing housing and ensuring that new residential development is compatible with Sausalito's small town character.
- Providing opportunities for a range of housing types in a variety of locations and densities to meet the diverse needs of the Sausalito community.
- Expanding and protecting opportunities for households to find housing in Sausalito and affording a greater choice of rental and homeownership opportunities.
- Reducing governmental constraints on the maintenance, improvement and development of housing while maintaining community character.
- Promoting equal housing opportunities for all residents, including Sausalito's special needs populations, so that residents can reside in the housing of their choice.
- Promoting environmental sustainability through support of existing and new development which minimizes reliance on natural resources.
- Promoting the active participation of citizens, community groups, and governmental agencies in housing and community development activities.
