**AMENDMENT TO A CONDITIONAL USE PERMIT AND**  
**DESIGN REVIEW PERMIT FOR AN EXISTING WIRELESS**  
**FACILITY AT RODEO AVENUE AND HIGHWAY 101**  
**CUP/DR 97-03**

**You are invited to attend a Planning Commission public hearing on the following project.**

**PROJECT DESCRIPTION** Applicant, Sprint, on behalf of property owner, the State of California, is requesting Planning Commission approval of an amendment to a Conditional Use Permit and Design Review Permit to modify a condition of approval in Planning Commission Resolution No. 2013-06 (approved February 20, 2103), which modified an existing wireless facility at a portion of the California Department of Transportation's Highway 101 right-of-way. Condition of Approval 3 in Planning Commission Resolution No. 2013-06, which requires that the Remote Radio Units (RRUs) be installed "on the pole at eight feet above the finished grade at the base of the pole", is requested to be removed. The applicant is requesting that the RRUs allowed to be installed behind the antennas at 38 feet above the finished grade.


**MEETING LOCATION** City Council Chambers at City Hall, 420 Litho Street, Sausalito
