SUBJECT:

November/December Tree Tip of the Month, 2014 Rotation Schedule and Template

Discussion:

• At the September 9, 2013 TVC meeting draft language for the November Tree Tip was discussed. The October meeting was canceled. Prior to the November 11 meeting Committee Member Rosenstein submitted the draft December Tree Tip.

• At the September 9, 2013 TVC meeting the TVC agreed upon a template to use for the Tree Tips. Chair Bickford agreed to send the template in an editable form to City staff to use.

• The TVC should agree upon a rotation schedule for Tree Tips during the 2014 calendar year.

Recommendation:

1-Review the draft language for November Tree Tip (see Attachment 1), make appropriate modifications and approve the Tip for publication; and

2-Review the draft language for the December Tree Tip (to be submitted separately) and make appropriate modifications and approve the Tip for publication; and

3-Provide an update as to the status of the tree tip template

4-Agree upon a rotation schedule for tree tips (see Attachment 2)

Tree Tip for November 2013

Are you having a disagreement with your neighbor regarding vegetation which may be obstructing your view? In order to file a request for an Advisory Decision by the City's Trees and Views Committee for a View Claim, the affected property owner must take several steps in an attempt to resolve the view obstruction with the owner of the tree.

- The first step requires the affected property owner to send the Tree Owner a written notice which outlines the concerns and includes an arborist report with a recommended solution. The arborist report must prepared in accordance with the requirements of the City.
- The second step requires the affected property owner to send a written notice to the Tree Owner requesting that the matter be submitted to mediation. The Tree Owner has 30 days to accept or reject the mediation request.
