## PROJECT DESCRIPTION

Michael Rex Architects, on behalf of Fay Mark and Russ Irwin, is requesting Planning Commission approval of the following at 509 Johnson Street (065-084-12):

- A Design Review Permit and Heightened Design Review to allow additions to an existing single family dwelling totaling approximately 984 square feet of floor area; and
- A Conditional Use Permit to allow tandem parking; and
- A recommendation to the City Council for the approval of an Encroachment Agreement in order to allow to modify and reconstruct an existing retaining wall adjacent to the sidewalk within the Johnson Street public right-of-way fronting 509 Johnson Street.
