- PROJECT DESCRIPTION** The applicant, Mike Monsef, proposes a project to convert approximately 105 linear feet of public parking spaces within the public right-of-way on the west side of Bridgeway into a parklet with 18 dining tables fronting the existing restaurants and delicatessen at 621, 625, 629 and 633 Bridgeway; APNs 065-132-01, 02, and 03.
